




This chart shows the total general purpose revenue STREAM Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for STREAM Charter School is \$8,050,284.00, of which \$5,867,644.00 is Local Control Funding Formula (LCFF), \$1,663,326.00 is other state funds, \$323,000.00 is local funds, and \$196,314.00 is federal funds. Of the \$5,867,644.00 in LCFF Funds, \$556,882.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



# Plan Summary [LCAP Year]

#### **General Information**

STREAM Charter School serves transitional kindergarten through eighth grade students, primarily in the greater Oroville area of Butte County since 2014. Our educational model emphasizes problem and project-based, inquiry learning and a collaborative and equitable approach to educating youth in a technology rich environment. STREAM emphasizes Science, Technology, Reading, Engineering, Arts, and Mathematics. We believe that a strong foundation in science and mathematics provides a critical component to a successful 21st century life and career. Our model integrates technology, literacy, and the arts throughout the curriculum. Students begin learning to code in Kindergarten and continue to grow throughout their time at STREAM. This integrated learning provides support that meets the varied needs of all students.

In 2023-24, STREAM served 481 total students with diverse needs and backgrounds; approximately 53.6% are socioeconomically disadvantaged; 4.4% of students are English Learners. In addition, 15% of students qualify for Special Education services. The LCFF unduplicated percentage is approximately 39%. Approximately, 58% of STREAM's students identify as being White, 13% as Hispanic, 12% as two or more races, and 11% as Asian.

## **Reflections: Annual Performance**

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

STREAM Charter School is proud of its 0% expulsion rate, 1.8% suspension rate, and 14.9% chronic absenteeism rate. We attribute these to the school climate action and we are committed to continuing to provide a positive environment for all students.

The positive culture at STREAM has been highlighted through survey results which demonstrate that 80% report awareness of opportunities for parental input into decision-making. Students and teachers have also given positive feedback with 80% of students responding that they feel safe, respected and a sense of belonging, and 80.9% of teachers reporting that they feel safe and connected to the school community.

Local Control and Accountability Plan

#### **Identified Needs**

Based on the 2023 CA Dashboard, the school has identified needs based on the Red status for students with disabilities in English Language Arts achievement and Red status for students with disabilities in Math achievement. To address this need, the school will utilize diverse instructional methods and curricula and regular assessments to monitor student progress. The school will continue to provide small group and 1 on 1 interventions to academically support its student population. In addition, we plan to increase our intervention efforts for students with disabilities.

Chronic absenteeism is also an identified need in regards to the Special Education subgroup. Students with disabilities were at the Red status level with 22.2% reported as chronically absent. In order to better support our Special Education students, we will be providing targeted efforts towards reengagement utilizing incentives. We also anticipate an overall reduction in the Chronic Absence rate for 2024 based on our parent involvement/outreach efforts.

#### Learning Recovery Emergency Block Grant (LREBG)

STREAM has \$24,168 in unexpended funds for the 2025-26 school year. The LREBG funded action can be found in Goal 1, Action 5 Interventions and Instructional Support.

The STREAM needs assessment substantiated findings from the 2024 CA Dashboard related to academic achievement in English Language Arts and Mathematics. A review of state and local data indicates Long-Term English Learners and Students with Disabilities have significant needs in these areas. The needs assessment found that students need additional instruction to meet grade level standards.

Based on this, Goal 1, Action 5 directly addresses these needs by providing academic support for those who are struggling in ELA and Math. This action falls under the allowable uses of the funds by furnishing additional aides to assist with intervention.

#### Goal Analysis 2024-25

Overall the actions designed to support achievement of the goal were implemented as planned, except that we replaced Mathletics with Savvas Math.

Successes with the action implementation process include the effectiveness of our primary intervention program. We have accumulated a great deal of informative data. In addition, we are focused on creating high quality professional development opportunities for teachers.

Some challenges with implementation this year include the fact that we are still in the process of refining our 6th-8th grade intervention program. In addition, we are looking to departmentalize grades 6 through 8.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The difference between the budgeted expenditures of \$1,787,519 and estimated actuals of \$2,185,254 for Action 1 is due to the fact that we hired additional staff because of increased enrollment. The difference between the budgeted expenditures of \$112,728 and estimated actuals of \$76,791 for Action 2 is due to decreased costs for administrative personnel. The difference between the budgeted expenditures of \$59,164 and estimated actuals of \$77,238 for Action 3 is due to increased educational software costs. The difference between the budgeted expenditures of \$49,146 and estimated actuals of \$94,478 for Action 4 is due to the fact that initially only a teacher stipend was budgeted, but that was changed to a a full salary. The difference between the budgeted expenditures of \$230,509 and estimated actuals of \$260,847 for Action 5 is due to increased staffing costs. The difference between the budgeted expenditures of \$49,147,830 and estimated actuals of \$96,658 for Action 6 is due to decreased staffing costs.

The actions of Teacher Hiring and Retention and Teacher PD and Coaching were effective in achieving 79% of teachers appropriately credentialed & assigned, as well as 100% of staff being peer observed/evaluated in the school year.

The Standards-aligned Curriculum & Assessment action was highly effective in achieving 100% students with access to standards-aligned instructional materials.

Local Control and Accountability Plan

Our English Language Development action was not very effective, as only 40% of EL students improved on the ELPAC this year. This represents a decrease from the prior year. We plan to prioritize the achievement of our English Learners in the coming year.

The actions of Interventions, Instructional Support and the Long-term Independent Study program were less effective this year in regards to our local benchmark testing with 41% of students meeting or exceeding standard in ELA and 29% of students meeting or exceeding standard in Math. This represents a notable decrease from the previous year. In addition, these actions were partially effective in achieving an average of 45% of students scoring proficient or advanced on problem solving skills based on PBL rubrics and 48% of students with a B or above GPA. Additionally, these actions were not very effective in regards to CAASPP performance as about 41% of students met or exceeded the standards on benchmark testing in ELA and about 29% of students Met or Exceeded the Standard on benchmark testing in Math. Although scores have decreased since last year, we expect 2025/26 scores to increase based on the intervention and strong instructional support programs implemented this year.

## Goal Analysis 2024-25

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Overall the actions designed to support achievement of the goal were implemented as planned, except we no longer implement the Pastry with the Principal program or participate in the Airport Fly-in, Feather Fiesta Days or the YMCA community events.

Successes with the action implementation process include that our attendance rate has remained steady at about 95%. We attribute this in part to the fact that STREAM's parents and families are very supportive of our program. In addition, Community Day was a huge success; local business owners and individuals were able to share their accomplishments.

Some challenges with implementation this year include that it has been a struggle to implement all the new programs we had planned to engage staff and students. We are seeking to add additional after school programming to engage younger male students. STREAM is also seeking more connections with multicultural groups.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The difference between the budgeted expenditures of \$16,438 and estimated actuals of \$29,595 for Action 1 is due to increased staffing costs. The difference between the budgeted expenditures of \$155,055 and estimated actuals of \$302,497 for Action 2 is due to higher than anticipated staffing costs. The difference between the budgeted expenditures of \$142,455 and estimated actuals of \$210,710 for Action 3 is due to increased staffing costs for the front office. The difference between the budgeted expenditures of \$15,000 and estimated actuals of \$23,835 for Action 5 is due to higher than anticipated community event costs.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The action of Attendance initiatives was highly effective in achieving the 94.81% overall Attendance rate, as well as a 0% MS Dropout rate and a 14.9% Chronic absenteeism rate, a 1.4% decrease from the prior year. While the majority of our subgroups saw a decrease in chronic absenteeism, both Hispanic and Asian student groups reflected an increase. We plan to prioritize these students in our efforts to continue to reduce the Chronic Absence rate for 2025 with our parent involvement/outreach efforts.

The actions of Parent Engagement and Parent Communication were partially effective in that 71% of parents reported a positive response to school safety and connectedness, 80% of parents reported a positive response to "parents have leadership opportunities and influence on decision-making at their school", and 59% of parents checked in each trimester on SIS grades.

Local Control and Accountability Plan

The action of Health/Safety/Facilities was highly effective in achieving a rating of "In good repair" for School facilities.

The action of Social Emotional and Behavioral Supports was highly effective in achieving 80% of 1st-8th grade students participating in service-learning projects and 80% of students reporting a positive response to school safety and connectedness. Additionally, these actions were highly effective in achieving a 1.8% Suspension Rate, as well as a 0% Expulsion Rate. These actions contributed to a positive school culture, which was highly effective in achieving a 97.29% Re-enrollment rate. This action was also partially effective in achieving a strong staff culture, with about 80% of teachers reporting a positive response to school safety and connectedness

The action of Community Engagement was highly effective in achieving 160 students on the waiting list, a decrease of 124 from the previous year. Many of these students successfully enrolled in our program.
